ORDER:

In the reference 2nd read above, the Managing Director, Telangana Housing Corporation Limited, Hyderabad has stated that the Collector & District Magistrate, Rajanna Sircilla District has informed that totally (10,683) Project Displaced Families (PDFs) under Mid Manair Reservoir project have been provided with house sites in (12) villages including hamlets under R&R package. Out of the above said PDFs, 5987 beneficiaries constructed houses and remaining 4696 beneficiaries not having own houses and requested to sanction 4696 houses under INDIRAMMA INDLU SCHEME for the remaining land losers/PDFs who are yet to Construct houses.

2. The Managing Director, Telangana Housing Corporation Limited, Hyderabad has therefore, requested the Government to consider the proposal of the Collector & District Magistrate, Rajanna Sircilla District for sanction of 4696 houses to the Project Displaced Families (PDFs) of Mid Manair Reservoir Project with @ Rs.5,00,000/- under State Reserve Quota (SRQ) of INDIRAMMA INDLU Scheme from the State Government funds as a special case, duly relaxing the eligibility criteria as prescribed in G.O.1st read above, wherever required.
3. Government after careful examination of the matter, hereby sanction (4696) houses to the Project Displaced Families (PDFs) of Mid Manair Reservoir Project with @ Rs.5,00,000/- under State Reserve Quota (SRQ) under INDIRAMMA INDLU Scheme duly relaxing the eligibility criteria prescribed in the G.O.1st read above, wherever required, as a special case.
4. The Managing Director, Telangana Housing Corporation Limited, Hyderabad and the Collector & District Magistrate, Rajanna Sircilla District shall take necessary action in the matter.
