Sub: S.E.Dept., -Caste Census - conducting of Caste Census in the state from 06.11.2024 spanning 03 weeks- Drafting the services of Staff of Primary School and MRCs to complete the survey-instructions-Reg.

The attention of Director, School Education, Hyderabad is invited to the subject cited and he is informed that, the Government has decided to conduct of Caste Census in the State from 06.11.2024 spanning a duration of three (3) weeks, for this purpose, Government intends to utilize the services of at least 80,000 employees of MROs, MDOs, MPOs, Asha and Anganwadi workers including teachers to complete the survey.

However, in this regard, least preference is being given for teachers, they are drafted to conduct the survey as there is a acute shortage of staff, and also not to cause any dislocation to teaching in schools.

He is further informed that the services of 36,559 Secondary Grade Teachers, 3,414 Primary School Head Masters working in primary schools throughout the State, 6,256 staff of MRCs and around 2,000 Ministerial staff of Government, MPP/ZPP and Aided Schools in the cadre of Typist Record Assistant, Junior Assistant, Senior Assistants are to be utilized for the purpose of conducting the survey.

He is further informed that, in order to utilize the services of SGTs and PSHMs of primary schools to conduct the caste census survey, Government is hereby decide to run the primary schools (Govt., LB & Aided) for half day i.e., from 09.00 am to 01.00 pm and the students may be let-off after serving Mid-Day Meals as per schedule, thereafter, the drafted SGTs and PSHMs shall attend the enumeration duties in coordination with Planning Department.

However, the services of Secondary Grade Teachers who are working in Upper Primary Schools and High Schools are exempted from these enumeration duties and these schools shall function as per schedule.

The drafted staff shall attend the enumeration duties for the whole day as per the instructions of the Planning Department on all the holidays and the planning Department shall pay the remuneration as per norms.

Therefore, the Director, School Education, Telangana, Hyderabad is requested to take necessary action accordingly.


